



Free Chicken for a Year Sweepstakes

OFFICIAL RULES AND REGULATIONS TERMS & CONDITIONS

In exchange for being permitted to take part in the Parker's Kitchen 'Free Chicken for a Year Sweepstakes' (the "Contest"), in addition to other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Entrant hereby agrees to be bound by the terms of these Official Rules and Regulations, Terms and Conditions (the "Official Rules").

1. **How to Enter:**

- o **NO PURCHASE NECESSARY TO ENTER OR WIN. YOU MUST BE 18 OR OVER IN ORDER TO ENTER THIS CONTEST.**
- o You (the "Entrant") can enter the Contest by making in-store purchases, excluding fuel purchases, (each, a "Purchase") using Entrant's Parker's Rewards account. Each Purchase using the Entrant's Parker's Rewards information at the time of purchase shall be equal to one entry in the Contest. Fuel purchases by themselves are specifically excluded from the Contest. In addition to the Purchases, Entrants can enter the Contest by submitting an entry form by mail. Such mail-in entry forms shall include the Entrant's full legal name, complete mailing address, phone number, date of birth, and email address on a 3" x 5" or 8" x 11" piece of paper. The Entrant's information shall be in ink and legible, and shall be mailed to Parker's Kitchen, Attn: Free Chicken for a Year Sweepstakes, 17 W. McDonough Street, Savannah, Georgia 31401. One mail-in entry per household. All mail-in entries must be postmarked no later than October 31, 2022. Incomplete, illegible, duplicate, corrupted or untimely Entries may be disqualified by Gregory M. Parker, Inc. ("Parkers"). Parker's does not assume any responsibility for lost, late, illegible, or misdirected entries. Entries must be submitted by the individual entrant. All Entries become the property of Parker's when submitted and will not be returned to entrant.

2. **Sponsored by:** Gregory M. Parker, Inc.: 17 W. McDonough Street, Savannah, Georgia 31401.

3. **Eligibility:** The Contest is open to legal residents of the fifty (50) states of the United States (including the District of Columbia) who are 18 years of age or older as of the date of entry ("Entrant"). The prizes are personal to the selected winner and are not assignable to any other person or entity. Employees, officers and directors of Parker's, its affiliates, and subsidiaries, are not eligible to participate.

4. **Duration:** Entries for the Contest will be accepted from September 7, 2022 at 12:00 A.M. Eastern Standard Time through November 1, 2022 at 11:59 P.M. Eastern Standard Time; provided, however, that all mail-in entries must be postmarked no later than October 31, 2022 (the "Contest Period").

5. **Limitation on the Number of Entries:** There is no limit to entries made via Purchases. Limit one mail-in entry per person. Additional mail-in entries will be disqualified, and Parker's

reserves the right to disqualify any person that submits multiple entries. Multiple, automated, bulk entries, or entries submitted by third parties may be disqualified, and may void all entries by that Entrant.

6. **Prize(s):** Two (2) total grand prize winners will be awarded 'Free Chicken for a Year', which consists of ten (10) gift cards valued at One Hundred Dollars (\$100) each that expire on November 30, 2023. There is a limit to one (1) prize per household. All prizes are nontransferable and must be accepted as awarded. No requests for substitution or replacement will be honored. Prizes may not be redeemed for cash value.

7. **Winner Selection and Notification:** Winners will be selected at random by Parker's from all eligible entries received. The selection of the winners shall be made on or before November 7, 2022. The winners shall be notified within Seven (7) days of the selections. The sole obligation of Parker's is to attempt to contact the winner via phone or email at the number or email address provided in the entry form. The winners will have Three (3) days from the date Parker's attempts to contact the winner to respond. If the prize is not claimed within the specified time period, an alternate prize winner may be selected from all eligible entries received. The original prize winner will forfeit all rights and have no further rights to any prize nor any claims against Parker's based on the forfeiture of their winnings or use of their submission. Return of prize or winner notification as undeliverable, failure to respond to notification, failure to reach the winner and/or failure to provide required proof of eligibility and release(s) in a timely manner will result in forfeiture by the Entrant and may result in selection of an alternate winner from all eligible entries received.

8. **Error Correction:** Parker's reserves the right to correct or change any and all printing, typographical or mechanical errors. If because of a printing or other technical error, or for any other reason, more prizes are claimed than the number set forth in these Official Rules, a random drawing will be held among all eligible claimants making purportedly valid claims to award the advertised number of prizes available. Only the number of prizes stated in these Official Rules are available to be won in the Contest.

9. **Odds of Winning:** The odds of winning depend on the total number of eligible entries received.

10. **Publicity Release and Affidavit of Eligibility:**

- o Where permitted by law, winners grant to Parker's (which grant will be confirmed in writing on request, but shall not be necessary to grant the rights herein), their subsidiaries, affiliates and those acting pursuant to their authority, the right to print, publish, broadcast and use, worldwide in any media now known or hereafter developed, including but not limited to the world wide web, television, radio, print, and social media, at any time or times, the winner's name, portrait, picture, voice, likeness, city and state of residence and biographical information for advertising and promotional purposes without additional consideration, notification or permission.
- o Except where prohibited by law, winners may be required to sign an Affidavit of Eligibility and Release or forfeit the prize. Failure to comply, or return any required releases and related documentation, may result in forfeiture of the prize.
